**NARRATIVE**

On Tuesday, December 9th, 2025, I, Officer Moran, was on patrol in marked cruiser Victor 12. At approximately 4:49 pm, Nantucket Police Department (NPD) Dispatch received a telephone call on the non-emergency line from number [REDACTED]. The caller sounded to be a male, [REDACTED] caller. The male caller identified himself as a [REDACTED] although this is likely to be a fake name provided. The caller proceeded to sing the "12 Days of Christmas" Christmas Carol with altered lyrics,

After gathering all information, I made my way to the above noted location. Additionally, NPD Dispatch made contact with the current Nantucket Fire Department (NFD) shift and advised them of the situation. As I was conducting my response, NPD Dispatch also made contact with the Massachusetts State Police (MSP) Fusion Center and spoke with Lt. Driscoll of the MSP. He was advised of the ongoing investigation. A short time following, I arrived on scene and parked in the area parking lot of 30 Main St. off of Union St. to keep the police presence as minimal as possible. I walked to the front of Ralph Lauren and made contact with two employees inside, [REDACTED]  
[REDACTED]

[REDACTED] explained to the two the situation at hand involving the Bomb Threat, and how this threat mimics the threat made against the store the previous evening. Although the likelihood of the threat being minimal to zero, I asked [REDACTED] if she could escort me through the interior of the store to ensure nobody had entered without their consent or knowledge. After completing a check of the entirety of the interior of Ralph Lauren, I deemed the store to be safe and clear of any threat. I then advised [REDACTED] that it appears these threats are going to match the theme of the "12 Days of Christmas" and to expect further calls in the following days. They advised me that the

store typically closes at 6:00 pm each day, however, they may begin to close at 5:00 pm in the near future. I advised both [REDACTED] that if these calls continue and no representatives are located in the store at the time of the call, we may contact them via their cellphone numbers and see if the building was clear and secure upon their exit. They both agreed and acknowledged.

I then gathered all identifying information and made my way to the storefront to evaluate the presents located under the store's Christmas Tree. I observed the packages, and identified no unusual odors, lighting, staining, liquids, noises, or vibrations coming from any package under the tree. I proceeded to then open each individual package which revealed the contents to be clothing hangars from within the store. No suspicious items were located in the area. After deeming the packages as well as the interior of the store to be safe, I cleared the scene and returned back to NPD.

Shortly following my arrival at NPD, I received a call from NPD Dispatch advising me that the suspect, [REDACTED] was actively on the non-emergency line and was wishing to speak with a "Detective [REDACTED]". It is of note that nobody by the name of [REDACTED] is currently employed or has been employed by NPD in recent years. I then had the call transferred to my desk's landline (ext. 5910), where I spoke with the unidentified suspect directly. I asked the male party what I could assist him with this evening. [REDACTED]

[REDACTED] At this time, I attempted to gather some understanding as to what the male suspect's end goal was with these threats he was continuously making. [REDACTED]

[REDACTED] I attempted to have the male suspect come to NPD to talk to me in person, however, he stated we would "just arrest him". After the male suspect appeared to realize I was not giving him the response he wanted, he began calling me [REDACTED] multiple times, [REDACTED] as well as [REDACTED] and failed to continue having a level-headed conversation. The phone call ended a short time following.

Within approximately ten (10) minutes of the first phone call ending, the male suspect identifying Moran, Jack W.

himself as [REDACTED] called back wishing to speak with an Officer once more. I again began speaking with the male suspect and asked how NPD could assist him this evening. The male party again began speaking cordially while calmly stating that he was going to "bring an IED (Improvised Explosive Device) to Nantucket Police Department and blow us up". The male suspect then stated, [REDACTED]. The male suspect continued by stating, [REDACTED]. After the male party made these multiple threats and statements, I asked him if he could tell me on what date and time he was going to follow through with these threats he has made. I also asked the male suspect if he could tell me how he was going to carry out these threatened attacks in an attempt to gather as much information as possible. Again, after failing to garner an emotional response from me, the male party began by stating, [REDACTED] numerous times, stated I was a [REDACTED] multiple times, and then began spamming the phone call by continuously stating [REDACTED] until ultimately ending our phone call. No further calls were made following the conclusion of this last conversation.

All audio files of the phone calls made by the male suspect to NPD Dispatch and I, have been attached to this Case File for future reference.

Due to the new threats that had been made, Sgt. Rockett and I completed a walk-around of the perimeter of NPD to ensure no suspicious items or people were in the immediate area. Nothing suspicious was discovered as a result of our search. It is of note that Sgt. Rockett, the Eve-Shift Supervisor, spoke with MSP Lt. Driscoll of the Fusion Center and notified Det. Lt. Mack of the situation at 7:05 pm, notified MSP Sgt. Bates of the situation at 7:12 pm, and notified NFD Chief Cranson of the situation at 7:15 pm. At the submission of this report, all appropriate personnel had been notified of the multiple threats that had been made.

I then cleared the call and returned to patrol. Nothing further at this time.
