**NARRATIVE**

On Saturday, January 3rd, 2026, I, Officer Moran, was on patrol in marked cruiser Victor 15. At approximately 6:16 pm, Nantucket Police Department (NPD) Dispatch received a telephone call from a male party identifying himself as [REDACTED]. The telephone number utilized was blocked, and no number or further identifying information were provided by the caller. The caller stated to NPD Dispatch operators that he had placed an Improvised Explosive Device (IED) at 16 Main St. (Ralph Lauren) and was armed with a "3D Printed" Glock pattern pistol. [REDACTED]

Shortly

following gathering all information, I made my way to 16 Main St. to conduct a preliminary sweep of the area.

Upon my arrival, I conducted a check of the immediate area surrounding the exterior of 16 Main St. for any suspicious packages, vehicles, or devices that shared characteristics of an IED. Nothing suspicious was discovered. Immediately following, I checked to ensure all entries into the building were secure, which I confirmed they were. Additionally, I scanned the interior of the building through the large street-side windows to look for anything suspicious within the store, any persons moving around, or any sign of recent activity within the store, which none were observed. While I was conducting the preliminary sweep of the area, NPD Dispatch confirmed with Ralph Lauren's Manager,

identified as a [REDACTED], that the building had been properly secured and no suspicious activity was observed prior to closing. [REDACTED] advised the store was secure and closed at approximately 5:10 pm this evening, and nothing suspicious was noted upon there exit. At this time, Ofc. Tirone arrived on scene to assist. Shortly following, NPD Dispatch advised that [REDACTED] stated Ralph Lauren [REDACTED]

While awaiting the arrival of NFD personnel, Sgt. Rockett advised Ofc. Tirone and I that the "Fisher Real Estate" camera located across from 16 Main St. at 21 Main St., had an active live feed and was capturing the building in question. Due to security concerns with the live feed possibly being monitored, I requested that NPD Dispatch contact a representative of Fisher Real Estate to terminate the feed during our investigation. A representative granted us permission to access the building and terminate the feed manually if necessary. [REDACTED]

by Ralph Lauren Management. After securing the scene, Ofc. Tirone and I cleared and returned to patrol.

This case remains under investigation pending further investigative leads.
